

Reported Cases

There were 396 total complaints brought to the Committee on Discipline's attention in academic year 2022-2023. The Committee on Discipline (COD), chaired by Professor Jay Scheib, resolved complaints by adjudicating cases of alleged misconduct. Of those 396 complaints, 344 (87%) were complaints alleging individual student misconduct and 52 (13%) were complaints alleging student organization misconduct.

Case Trend

The total reported number of cases decreased by 32% from the prior year. Reports of academic misconduct decreased by 15%. Student organizational misconduct reports increased by 63%.



The above stacked bar chart, entitled "Complaints by Type July 2013 to June 2023," shows that the number of cases reported to the COD over a ten-year period. The chart

shows the number of cases reported to the COD in each academic year: 211 cases in 2013-2014; 241 cases in 2014-2015, 255 cases in 2015-2016, 279 cases in 2016-2017, 232 cases in 2017-2018, 286 cases in 2018-2019, 290 cases in 2019-2020, 812 cases in 2020-2021, 584 cases in 2021-2022, and finally 396 cases in 2022-2023 as noted above.

The tables below summarize alleged policy violations from 2022-2023 compared to previous years. There is often more than one alleged policy violation per complaint, so there are more alleged policy violations than total complaints.

Case Resolutions

The COD utilizes resolution methods as described in the <u>Rules of the Committee on</u> <u>Discipline</u>. The COD and Office of Student Conduct and Community Standards saw an increase in cases that resulted in non-adjudicative resolution methods including conflict mediation, referral to other office, or educational interventions.

* Dismissal is not the same as a finding of not responsible. It means that the situation did not rise to the level of a possible policy violation, but still may have involved educational follow up.

Case Outcomes

COD strives to meet its educational philosophy of student accountability through intentional educational sanctions (e.g., substance use education, mentoring programs, projects, reflections, workshops, etc.). Through these structured sanctions, students learn about various interpersonal skills and are able to reflect on their own personal development. A small number of cases (0.5% in 2022-2023) require a student to be separated from the Institute, either temporarily or permanently. 99.5% of cases are resolved without suspension or expulsion.
